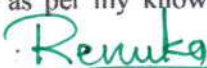
4. The school will get reimbursement as per Section 12 (2) of the Act, in respect of the children specified in Paragraph 3. A separate bank account shall be given to the School for getting such a reimbursement.
5. The Society/ School shall not recover any Capitation Fees and shall not compel any child or his/her parents or guardians for any scrutiny procedure.
6. No child shall be rejected admission in the school for lack of proof of age, religion, caste or race, place of birth or any of these reasons.
7. (One) Any child given admission in the school shall not be repeated in the same standard in which he is studying or will not be removed from the school until the primary education is completed.
(Two) No child shall be given physical punishment or mental torture.
(Three) It will not be necessary for any child to pass the examination of any Board till the primary education gets over.
(Four) Each child completing primary education shall be given a Certificate determined under Rule 23.
(Five) The students with disabilities/ special children will be included as per the provisions of the Act.
(Six) The Teachers holding minimum qualification determined under Section 23 (1) of the Act shall be appointed. But provided further that, those teachers who does not hold such minimum qualification at the date of initiation of the Act, will have to acquire such a qualification within 5 years' period.
(Seven) The duties specified in Section 24 (1) of the Act shall be performed by the teacher himself/ herself, and
(Eight) The school shall make sure that the teacher will not involve himself/ herself in the work of private tuition.
8. The School shall follow the curriculum prepared on the basis of the syllabus determined by the Competent Authority.
9. The School shall give admission to the children in school in comparison with the facilities available in the School as is prescribed in Section 19 of the Act.
10. The School will follow the standards and authenticators specified in Section 19 of the Act. In the previous inspection the facilities available in the School were as follows:-

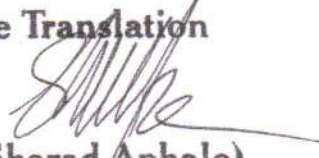
